The Government is looking to reorganise all local authorities into large unitary authorities, as this is thought to								
be more efficient.								
A proposal for West Berkshire Council to join the Vale of White Horse and South Oxfordshire District Councils								
into a unitary authority, with the proposed name being Ridgeway Council is out for public consultation until 16								
July 2025. A series of public consultation events are also being held across the district at which residents can								
discuss the plans. Have your say on proposal for two new councils for area - West Berkshire Council
